विषय:-Selection of Chief Vigilance Inspector (Ex-Cadre post) in Vigilance Deptt., DMW/Patiala.

Applications are invited from the eligible and willing staff, for filling up one post of Chief Vigilance Inspector in Level-7 (GP4600/-) on ex-cadre basis. The applications in the prescribed Performa (attached herewith) may please be forwarded to this office on or before 31.03.2021.

Posting in Vigilance Cell will be on tenure basis, but the administration reserves the right to repatriate the staff at any time, even before the expiry of tenure without assigning any reasons what-so-ever.

The post will be filled up by positive act of Selection but normal Establishment Rules applicable to regular Selection Posts are not applicable in case of selection of Vigilance Inspector as special case.

Selection will comprise of Written Test followed by a Vigilance Aptitude and Computer Knowledge Test. The candidates who obtain at least 60% marks in the written test will be called for Vigilance Aptitude and Computer Knowledge Test. The distribution of Marks for selection is stated below:

ELIGIBILITY:

1. The applicant should have been drawing pay in Level-7 (GP4600/-) or above on account of Regular promotion (or under MACP). The applicant should have proficiency in Hindi, English, good knowledge of Rules and Regulations of Railway and should have an analytical bend of mind and a clean record of service.
2. The staff should have completed at least five years of service in Railways as on 16.03.2021.
3. The staff who have already completed their tenure in Vigilance Organisation as Vigilance Inspector are not eligible to apply now.
4. The staff should have sound integrity, should not be figuring in any current Vigilance/SPE/D&AR case and should not have been imposed any major/minor penalty in any past vigilance case.

Candidate selected as Chief Vigilance Inspector will be required to give a written undertaking that he will not undertake the role of Defense Assistant to any charged official in any Vigilance case for a period of four years from the date of his leaving Vigilance Organisation.

This should be given wide publicity amongst the eligible staff.
